FIRST PRESIDENT'S COMMITTEE MEETING, 4 P.M., JUNE 18, 2009

President Eddie Griffith called the meeting to order and Recording Secretary Pat Merritt called the roll. Present: President Eddie Griffith, 2nd VP Don Mixon, Secretary Pat Merritt, Chairman of Directors Fred Roush, Treasurer Walter Bisselle, Executive Secretary Val Longson. Absent: 1st VP Wayne Cameron.

President Griffith announced that all Committees would meet as a Committee of the Whole, and listed several agenda items he wanted to discuss at this meeting that may then be referred to the appropriate committees for possible action and then presented to the full Board of Directors at its meeting on Friday:

- ∞ Location of the 2010 Convention.
- ∞ In 1st VP Cameron's absence, who should chair the Show and Judging Rules Committee?
- ∞ Whether Amateur Exhibitors must be present to enter their blooms.
- ∞ Review the seedling problem that occurred at the April 26, 2009, Lone Star Chapter show.
- ∞ Review and publish the Head Table set up at shows.
- ∞ Review the show-scheduling conflicts within the regions.
- ∞ Divide Texas and Louisiana into two separate regions?
- ∞ Improve and increase hibiscus culture articles in *The Seed Pod*.
- ∞ Review the progress on the DVD Catalogue.
- ∞ Review the progress on the Nomenclature Database.
- ∞ Review the policy on new Seedling Evaluation Committee members rating plants they haven't evaluated very long.
- ∞ How many times should the SEC's Designated Grafter be required to replace plants?
- ∞ Increase the time between when the Designated Grafter receives seedling wood and plants are shipped to the evaluators to nine months.
- ∞ Reminder to all hybridizers not to enter a seedling in a show that he/she has not evaluated in all seasons, and that they must furnish enough wood to the Designated Grafter to produce 12 plants.

The above items were discussed and were referred to the appropriate committees.

FIRST BOARD OF DIRECTORS MEETING, 5 P.M., JUNE 18, 2009

Chairman Fred Roush called the meeting to order and Recording Secretary Pat Merritt called the roll. Present: President Eddie Griffith, 2nd VP Don Mixon, Secretary Pat Merritt, Chairman of Directors Fred Roush, Treasurer Walter Bisselle, Executive Secretary Val Longson; Directors Cindy Erndt, Paul Felsberg, Joyce Comingore, Kathy Grandoff, Wanda Schmoyer; Immediate Past National President Sam Andrews; Chapter President's Coordinator Wally Neef. Absent: 1st VP Wayne Cameron, Directors Bradley Christian and Ed Flory.

Chairman Roush read a proposal from Randy Cox suggesting that the Hibiscus of the Year competition be changed to allow each hybridizer who wins a Best of Show Seedling at a sanctioned AHS show to choose to submit a seedling bloom of his/her choice for evaluation, not necessarily the bloom that won. After discussion, a motion was made and seconded to allow a hybridizer to replace his/her bloom that won BOS Seedling with a seedling of his/her choice to be submitted to the Seedling Evaluation Committee for HOTY consideration. The motion failed unanimously.

Pat Merritt asked the Board to consider changing the present designation of Hibiscus of the Year (HOTY) to Seedling of the Year (SOTY) to more accurately describe this award. After a brief discussion, a suggestion was made to table this until the Board could have time to think about the matter.

Mrs. Merritt informed the Board of the death of Dr. Jana Downing, founding member of the British Virgin Islands Chapter in Tortola, BVI. Thanks to Jean Burns in St. Croix for sending this information.

Director Joyce Comingore handed out updates and revisions to the Policy and Procedures Manual. She volunteered at the November Membership Meeting to keep these pages updated.

2010 Convention Location

Executive Secretary Val Longson investigated several properties for this Convention and recommended to the Board that it be held at the Embassy Suites Hotel in Lake Buena Vista (Orlando), Florida. On motion made and seconded, the Board voted unanimously to accept Ms Longson's recommendation.

Amateur Exhibitors

After considerable discussion, the Board voted to keep the current rule in force. An Amateur Exhibitor must be present to enter his/her blooms except under unusual circumstances. The Show Director and/or Show Chairman may make an exception on a case-to-case basis.

Lone Star Chapter Show I Seedling Winner

Background: At the April 26, 2009, Lone Star Chapter Show, Barry Schlueter's Mellow Yellow won Best of Show Seedling, Don Florus' Texas Wild seedling won Best Regular Seedling Double, and Mr. Florus' Foxy Mama won Best Miniature Seedling Single. There was no Miniature Seedling Double. On Monday, April 27, when the show results were posted on the Internet, Randy Cox posted an email on the AHSBiz and THML Lists that Mellow Yellow was listed on Barry Schlueter's web site as having been optioned by Hines Nursery for propagation and sale in commerce. Hines Nursery was in Chapter 11 Bankruptcy proceedings and never propagated Mellow Yellow for sale. The hybridizer withdrew Mellow Yellow from the show and apologized for the inconvenience. The Show Director contacted all of the judges at that show and asked them to vote for one of the other two head table seedling winners. The vote for Texas Wild was unanimous.

This was referred to the Show and Judging Rules Committee for a recommendation.

Mr. Felsberg presented to the Committee a DVD (digital virtual disc) with 3,309 hibiscus images that will become the digital catalogue sponsored by the Chandler Cox Foundation. The chairman recommended that the AHS furnish one of these DVD's to each paid AHS membership at no charge, and post on the AHS web site that a disc will be mailed to each new paid membership. The disc will be available without membership for \$29.95, which includes shipping and handling.

After discussion, on motion made and seconded, the Committee will present this proposal to the Board at its meeting later today.

Also discussed was using some of the Foundation grant funds to produce other PowerPoint programs on hybridizing, grafting and rooting cuttings for use at Chapter meetings. The cost of producing these programs is minimal.

Publications have been moved to a smaller storage unit, cutting our rental costs by about 50%.

A culture article/column for *The Seed Pod* was discussed, and Pat Merritt will ask Barry Schlueter if he would consider writing it.

Roland Gaudet was successful in finding a printer to produce new Exhibitor Cards for the Amateur and Miniature classes for less than \$500. The need to find a sponsor for these cards is critical. When we are faced with reprinting a quantity of these cards in all classifications, the cost will run into thousands of dollars.

NOMENCLATURE COMMITTEE, 9:30 A.M., JUNE 19, 2009

Chairman Sam Andrews called the meeting to order with members Pat Merritt, Lynn Andrews, Marti Graves, Cindy Erndt, and Chairman Andrews present. Mr. Andrews introduced Dr. Pat Hegwood, professor of horticulture at Louisiana State University, who runs the Burden Center. LSU is hosting the American Hibiscus Society's Nomenclature Database. Dr. Hegwood thanked the AHS for the \$6,000 grant with which Mr. Sam Razi hired graduate assistant Michael Avinash to do the programming. The project is almost finished, and the linking of the hibiscus images will be the last step. Dr. Hegwood and Dr. Rodney Hendrick presented a PowerPoint program charting the progress of the work on the Nomenclature Database, which should be online and ready to use by everyone by Labor Day. Some of the features identified in the program were

- ∞ Easy-to-use online registration form.
- ∞ Ability to reserve names for hibiscus blooms up to 12 months (must be renewed at the end of one year).
- ∞ Searchable fields.
- ∞ Registrations in Excel format are importable into the database.
- ∞ Has the capability of combining all existing hibiscus nomenclature databases into this one.
- ∞ The stability and security of a prestigious university behind it.

The current International Cultivar Registration Authority for Hibiscus rosa-sinensis Brian Cheers of Australia has been very cooperative with this project, but he has had some health and computer problems recently.

There followed a lengthy discussion among the committee members about technical issues dealing with finishing the web site.

Thirteen of the fifteen Chapters had presidents attending or were represented by another member. Getting new members is the main focus from most chapters. The Hendry Chapter signed up nine new members at their show by offering \$3 off on each plant with a new paid membership. The Red Stick Chapter offers two free plants with a paid membership at the show. The first one is given to the new member at the show, and they can pick up the second one when they attend their first meeting. The Space City Chapter had its best show season this year partly because of Hurricane Ike. Many people in that area lost everything in their yards and came to their three shows to replace their hibiscus plants. It helps greatly to have shopping carts available if you have the room in your show venue. Many do not. The Sunrise Chapter makes more money on their two Chapter auctions each year than on their show plant sale. The bottom line from every Chapter was publicity makes your show. Make friends with your local newspaper's garden editor and try to get a mention in the paper the day before your show.

SHOW AND JUDGING RULES COMMITTEE, JUNE 19, 2009

Second VP Don Mixon called the meeting to order in the absence of First VP Wayne Cameron. Members present: Paul Felsberg, Marti Graves, Zelma Neef, Bonnie Orpi, Pat Merritt, and Bobby Dupont.

This Committee ran concurrent with the Judges Seminar. A list of judges attending was sent to the 1st VP for his records.

A proposal for a judging rules change was presented to the committee that, during the Gold Seal judging, judges abstain from voting in the classification in which they exhibit. At most shows, a bloom will win by only one or two votes. If there are husband/wife judging teams, they can sway the vote for their bloom. In the discussion that followed, some of the negative points were: a TX/LA show may only have four or five judges, and nearly every exhibitor will have blooms in the Miniature classification. It was acknowledged that the rule will have to be tweaked somewhat. After discussion, on motion made and seconded, this rules change, if approved by the Board, will be tried for one show season. This will begin with the Conrad Sunrise and Harry Goulding Chapters' shows this fall. A report will be made to the Board at the Fall Membership Meeting. This motion carried unanimously.

At the Lone Star Chapter Show I on April 26, 2009, an exhibitor entered a seedling that won Best of Show Seedling. The next day it was reported on the AHSBiz and THML lists that this seedling had been offered in commerce and was, therefore, ineligible for this award. The hybridizer withdrew it. The Show Director reconvened the judges via email, posted pictures of the two other head table seedling winners and asked them to vote for one of them to replace the withdrawn seedling. The judges unanimously voted for Texas Wild, and that seedling was turned in to the Executive Secretary as the Best of Show Seedling for that show. Because of the "Seedlings Do Not Move Up" rule, the Lone Star Chapter is asking for a one-time exception to this rule to allow this show to have a seedling winner. A motion was made and seconded to allow this one-time exception for Mellow Yellow to be replaced by Texas Wild. After discussion, the motion carried unanimously.

A brief discussion about positioning blooms on wires (facing forward or straight up) resulted in the committee telling the Show Directors to use their common sense in arranging the blooms to their best advantage.

The Committee next reviewed the current Miniature List and made several corrections to it.

President Griffith thanked all of the judges for traveling to shows, and stated that the judging process in Florida had gone very smoothly. He reminded the judges present to move the process along by not taking too long on any one bloom. A competent judge should be able to look at a bloom and tell if it should be a Gold Seal bloom.

A suggestion was made to separate the tracking and managing of the judges from the office of the First Vice President. That job already has a lot of responsibility, and the tracking of judges needs some continuity. This should be brought up at the Board meeting.

Bonnie Orpi gave a presentation on bloom preparation for shows.

Chairman Rod Hendrick called the meeting to order with the following members present: Sam Andrews, David Tate, Kathy Grandoff, Greg Graves, Rod Hendrick; Absent: Pete Conrad, Gayle Morrison, Annelle Cox, Bradley Christian.

The chairman announced that Gayle Morrison has resigned from the committee.

Chairman Hendrick led a discussion about the timing of delivering wood from winning seedlings to the designated grafter. Wood from winning blooms must be submitted by November 1 of the year they win. Growing plants must be furnished to SEC members by Convention of the following year. There are at least two fall shows in Florida, and it is impossible to get wood to the grafter by November 1.

The chairman's computer malfunctioned and the evaluation numbers for 2006 and 2007 were wrong. He will redo the evaluation sheets and a special meeting will be held later.

The committee members discussed the individual blooms under evaluation for 2006, 2007 and 2008.

The chairman nominated Cindy Erndt, Lone Star Chapter, Alvin TX, to be a member of the Seedling Evaluation Committee. On motion made and seconded, Cindy Erndt's nomination was approved unanimously.

Chairman Rod Hendrick told the committee that Jim Gedicke has offered to enter the evaluation information in Excel spread sheets.

Corrected summary sheets for 2006 and 2007 were handed out to members and discussed.

The chairman again asked the Committee about allowing a hybridizer to insert a seedling of his/her choice for this year and have plants delivered to the SEC members in November 2010. This died for lack of a motion.

The chairman again asked the Committee about allowing a winning hybridizer to substitute a bloom for the one he/she won with. This died for lack of a motion.

Chairman Hendrick made a motion that the seedling winners at the fall shows have until October 15 of the following year for plants to be delivered to the members. The vote passed unanimously.

Changing the designation of Hibiscus of the Year to Seedling of the Year was briefly discussed, then tabled until the November Membership meeting.

Absent: 1st VP Wayne Cameron, Directors Bradley Christian and Ed Flory.

Paul Felsberg proposed to the Board that a copy of the DVD Catalogue be given to each membership at no charge. Each Chapter will receive 10 copies to use for fundraising or as they see fit. The funding for this was provided by a Chandler Cox Foundation grant. On motion made, seconded and unanimously carried, the Board approved having 1000 DVD Catalogues made and distributed to the membership. Mr. Felsberg will handle this.

On motion made, seconded and unanimously carried, the Board confirmed the President's Committee's approval to add Cindy Erndt to the Seedling Evaluation Committee.

Chairman Roush was appointed at the Membership Meeting last November as Seedling Evaluation Committee Clerical Manager. He now feels that this position is redundant and resigned. The Board did not replace him, but reserved the option to appoint someone to replace that position at a later date.

A suggestion was made that the tracking of judges and judges-in-training be separated from the office of First Vice President to ensure continuity of this important function. This would require a bylaws change and was tabled until the November 2009 Membership meeting.

Nomenclature Committee Chair Sam Andrews presented a motion to the Board that the Nomenclature Database be named the Roz Merritt Memorial Nomenclature Database for Hibiscus rosa-sinensis on the Acknowledgement Page on the web site. The motion was seconded and carried unanimously.

Seedling Evaluation Committee Chair Rod Hendrick proposed that the SEC summary sheets evaluating the HOTY candidates by years be posted on the AHS web site.

Acting Show and Judging Rules Committee Chair Don Mixon presented to the Board a proposal passed by that committee at its meeting earlier in the day. That judges abstain from voting in their exhibitor classification during final Gold Seal judging if they have blooms in contention. This would also apply to final Best of Show voting. On motion made and seconded, the proposal carried unanimously.

Acting Chairman Mixon presented a request made by Marti Graves, President of the Lone Star Chapter that a one-time exception be allowed to replace the winning Best of Show Seedling Mellow Yellow with Texas Wild. Please see details in the Show and Judging Rules Committee Minutes. On motion made and seconded, and after a lengthy discussion, the request was approved by a vote of 6 to 5 with two abstentions.
